FARM, ANIMAL ACTIVITY & FIELD TRIP LIABILITY WAIVER, RELEASE, AND ASSUMPTION OF RISK (Florida Law)

This Liability Waiver and Release ("Agreement") is executed by the undersigned participant, or the parent/legal guardian of a minor participant, in favor of Global Kingdom Academy, including its owners, officers, employees, volunteers, agents, affiliated churches or schools, and representatives ("Released Parties").

1. Scope of Activities

This Agreement applies to participation in all farm-based, educational, recreational, religious, or enrichment activities including, but not limited to: school field trips, workshops, church programs, camps, demonstrations, animal interaction (including goats), walking tours, feeding, grooming, learning stations, and related activities occurring on or associated with the farm premises.

2. Acknowledgment of Risk

I understand that farm and animal activities involve inherent risks including, but not limited to, slips, falls, uneven ground, animal behavior such as biting or kicking, exposure to allergens, insects, weather conditions, and farm equipment. I acknowledge that animals are unpredictable and that injuries may occur despite reasonable supervision.

3. Assumption of Risk

I knowingly and voluntarily assume all risks, both known and unknown, associated with participation in these activities for myself or my child.

4. Release and Waiver of Liability

To the fullest extent permitted by Florida law, I hereby release, waive, discharge, and agree not to sue the Released Parties from any and all claims or causes of action arising from participation, including claims resulting from the negligence of the Released Parties, except as prohibited by law.

5. Indemnification

I agree to indemnify and hold harmless the Released Parties from any claims, damages, losses, or expenses, including attorney's fees, arising from my or my child's participation.

6. Medical Authorization

I authorize Global Kingdom Academy to obtain emergency medical treatment if necessary. I understand that I am financially responsible for any medical expenses incurred.

7. Florida Agritourism Notice

WARNING: Under Florida law, an agritourism operator is not liable for injury or death of a participant resulting from inherent risks of agritourism activities, including risks related to animals, land conditions, and natural hazards.

8. Minors

If the participant is under 18 years of age, the undersigned certifies that they are the parent or legal guardian and consent to the minor's participation.

9. Governing Law

This Agreement shall be governed by the laws of the State of Florida. Venue shall lie exclusively in Florida courts.

10. Acknowledgment

I have read this Agreement, understand its terms, and sign it freely and voluntarily, acknowledging that I am waiving important legal rights.
